MAYORS REPORT - Rick Whetsel, Mayor

- Mayors Court Report:
 - o 12 Cases = 1407.00 to General Fund
- Onsel Properties on Union St. is coming to the Village via a donation. All paperwork is in progress at the county level.
- Will be voting on Resolution #661 Amounts and Rates from the County Auditor for 2020.
- Fire Auxiliary donations for the Halloween Parade.
- CDBG Grant at county level for approval.
- Mayor wants to zone the village into six zones so that each councilperson will have a zone and better tend to daily operations of the village. The mayor is tasking the street comm. with the breakdown of zones. The mayor wants this accomplished by next council meeting.
- Water District Mayor stated there will be no city water coming into Risingsun.
- There has been some damage done to the Post Office after hours. Rick has talked to the Post Master and if this persists, the Post Office will be closed when not manned with an employee.
- FYI car break-ins have started again in our surrounding communities. Please be vigilant and keep your property securely locked.

Fiscal officer's office never sees a dual moment that is for sure. Busy this month with closing the gap between First Federal and UAN (accounting software), I was able to get the unpaid withholdings taken care of which brought me to around \$9,000.00 of my goal. This is why you see all of the "electronic withdrawals" on the first part of the payment listing totaling \$19,702.80 of unpaid withholdings from 2017 and 2018. I was also able to get refunds from overpayments to the IRS and State of Ohio. This money has been put into the general fund.

I scheduled some training coming up in October: Village Officer Training in Perrysburg on Oct. 16, 2019 cost (\$100.00). Poggemeyer Grant class on October 29, 2019 in Bowling Green (Free).

I have officially changed the letterhead, fax lead sheet and the court reporting information to following the new look. In addition, I have started deconstruction of the zoning forms and files. I will be putting a modern spin on things and relaunching soon.

Finance committee met and have developed a game plan moving forward to get this first timer through the budget process. I am super excited to show the committee how things work in the office and the UAN system.
