## STREET COMM. - (Conner, Woodruff, Thomas) - Mike Cox "Town Man" - St. Dept.

- Mayor Whetsel asked the Street Comm. to get with Gena and put together job description(s) and a paid leave schedule for Street Dept. and Fiscal Officer position(s).
- Heater in Police / Maintenance Bay wouldn't light. Bob's heating was out to fix as well as installed a switch in the lobby of the hall.
- Have about 1000# of salt on the truck. Hoping that gets me through the year.
- Per Jake at Bob's Plumbing and Heating. \$1200. to \$1400. for a new 30 gal. water heater in the park building.
- > He's still waiting for a limit switch for the Town Hall building. On back order.
- Been working on remodel of the bathrooms. Ground the floors down to bare and patched some concrete in preparation for Epoxy floor. Painted the walls and ceiling in bathrooms and repainted the walls in the hall. Had 8 gallons of paint left from when the Firefighters repainted the truck bays. They said that we could have it since it was about 15 years old. Still have about 4 gallons left.
- Bought new vanities and sinks. I'm not sure how the old ones didn't fall off the wall. The mounts just crumbled when we pulled the sinks off. The vanities are the cheapest Menards had to offer. Probably will only last a few years but I can build better out of solid wood when I have more time.
- Removed the stall dividers and took them to my shop. In the process of refinishing them. They are historical to the building so I will do all I can to keep them.
- Hopefully will have the floors done by the time of this meeting.
- ➤ Have been discussing with Gena the feasibility of moving the street department completely out of the town hall to the bus garage, making the space available to the PD. Not sure how that will affect the finances since the Street Dept. pays part of the bills for the building.

Your Firefighters are currently doing a complete inventory of village assets and cataloging them with serial numbers to provide better tracking of equipment.

This is a continuing project that will likely take a few months.

Tablets:

The new tablets were purchased and assigned to Chief/Mike, Captains/Kyrt and Perry Engineer/Tyler.
