# FISCAL OFFICERS REPORT and FINANCE COMM. – Gena Rathburn, Fiscal Officer / Clerk (Comm. Morse, Rodriguez, Vacant)

Will table the assignment of a new member to this committee, until the open council seat has been filled.

## STREET COMM. - (Conner, Woodruff, Thomas) - Mike Cox "Town Man" - St. Dept.

- Pressure washer was purchased will be split between the Fire and the Hall.
- New mower has made a major reduction to the mow times and gas consumption.
- Did hit a village residents' car with a rock that left the mowing deck by the railroad. Possible claim to come out of this, as there was minor damage done to the vehicle.
- New tires that were budgeted for the dump truck have been installed. They did find a wheel stud bent upon installation. This will be fixed sometime late April / May.
- Dirt in curb lawn in front of the flag pole at Town Hall was removed for curb repair.
- Would like to purchase playground mulch. 45.00/yd Dierksheide instructed Gena and Mike to work together to see if the funds are there, as the park levy is not generating revenue.
- Brush bins are working well and people are starting spring clean up.

#### FIRE DEPT. - Chief Mike Cox.

- Perry Hartley was the only candidate for the 1st Captains Position. Would like to get him appointed.
- Support Staff. Description has been submitted just waiting on council approval.
- This month's training was Hazmat done by Bad Day Training and Consulting.
- Ordered new helmets for the department.
- Purchased a Halligan bar for the department as we have seen a need.
- Appointments of Lieutenants will be next.

#### POLICE DEPT. - Chief Shawn Beckley

Lexipol Gold Level achieved in policy management.

- Training: 24 hours required CPT 8 online and 16hrs in person. Only paying for 4 officers training for the year. 3 officers attended Active Shooter Training; this was paid for thru a state grant.
- Leads Audit: Passed
- Cook Out with A Cop May 24, from 11 1p.
- Firearms Qualifying in August.

#### HISTORICAL SOCIETY - Sandy Stephenson

Sandy stated that the Historical Society will have the Opera House open for the GOBA event in June. The display will stay the same as currently it is "Businesses of the Village"

### ZONING REPORT - David Feahr (President of Zoning Board)

- Still working on ordinances. The Amplex permit was submitted for review prior to the meeting and was given back by Mayor Dierksheide to have some changes made.
- Board has a few addresses to start looking at and handing out "Fix it Tickets". Morse stated that some clarification is needed as he believes these would be grandfathered in and therefore would not be able to receive a ticket.
- Mayor Dierksheide stated that he needs to have meeting minutes to the Clerk so they can be available for public records and be approved by council.

#### FINANCE COMM. - Nothing to report

#### **OLD BUSINESS:**

- Codification Gena to get to this in 2025.
- Route 23 property is still being worked on.
- Fire Auxiliary has been resolved.
- GOBA meeting April 15th Mike Cox attended. He stated this meeting was for emergency services only and that the meeting went well.

#### **NEW BUSINESS:**

Juanieta Rodriguez – Report to council on RCC (Risingsun Community Corp) event coming up May 31st from 8a.m. to 1 p.m. This will be a community clean-up day for the village residents. Flyer to come soon. You will need to prove residency. They will have dumpsters, drug take back, gun lock, Roth tags, electronic disposal. This will be put on with the help from Ambulance District 150, Local Fire Dept., Sheriffs Dept. Next meeting will be May 15th at 6:30p at the park building 550 Salem St.

Morse asked if the village could pay for the cost of the disposal?
