A RESOLUTION OF THE COUNCIL OF THE VILLAGE OF RISINGSUN TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF RISINGSUN ON NOVEMBER 5, 2025, THE QUESTION OF APPROVING A RENEWAL OF THE 5 YEAR 2.0 MILL LEVY IN EXCESS OF THE TEN MILL LIMITATION WHICH WAS PASSED NOVEMBER 3, 2020 FOR THE GENERAL CONSTRUCTION, RECONSTRUCTION, RESURFACING, AND REPAIR OF STREETS, ROADS, AND BRIDGES WITHIN THE VILLAGE

WHEREAS, by Resolution 2025-002, passed on February 25, 2025, the Council of the Village of Risingsun has determined that the amount of monies that may be raised within the tenmill limitation by levies on the current tax duplicate will be insufficient to meet the costs of general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges within the Village; and

WHEREAS, at the general election held on November 3, 2020, the electors of the Village of Risingsun approved a five (5) year, two (2.0) mill levy in excess of the ten (10) mill limitation for the expenses of general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges within the Village; and

WHEREAS, the assessment of the monies generated by said levy were placed on the tax duplicate effective January 1, 2020 and were collected on or after January 1, 2021 and thereafter for a period of five (5) consecutive years; and

WHEREAS, the Council of the Village of Risingsun has determined that in order to meet the expenses of the general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges within the Village, it is necessary to renew said levy for an additional period of five (5) years against the real property located within the Village; and

WHEREAS, Ohio Revised Code §5705.19(G) permits the collection of such a tax for the expenses of the general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges within the Village; and

WHEREAS, the Wood County Auditor has provided its Certificate of Estimated Property Tax Revenue to the Village as required by law, which certificate states that the property valuation of the Village of Risingsun for purposes of estimating this proposed property tax renewal levy is \$8,404,080.00, and that the proposed two (2.0) mill renewal levy will produce an estimated annual revenue of \$12,000.00 for the life of the levy, provided tax valuations in the Village remain constant throughout the levy; and

WHEREAS, the Council of the Village of Risingsun desires to submit the issue to the electors of the Village at the November 5, 2025 General Election, in compliance with RC §5705.191.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF RISINGSUN, WOOD COUNTY, OHIO, WITH TWO-THIRDS OF ITS MEMBERS CONCURRING, THAT:

SECTION 1: That for the purpose of continuing to provide the necessary additional funds for meeting the expenses of the general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges within the Village, it is necessary to pass a renewal of the existing, additional five (5) year, two (2.0) mill street levy as authorized by Ohio Revised Code Section 5705.19 (G); that it is necessary to levy said tax outside of the limitations imposed by Section 2, Article XII, of the Ohio Constitution; that said renewal of the now existing additional, five (5) year, two (2.0) street expenses levy shall be submitted to the electors of the Village at the general election to be held on November 5, 2025, in order that said levy, if approved by the voters, may be placed on the tax duplicate effective January 1, 2025 to be collected on or after January 1, 2026 and thereafter for a period of five (5) consecutive years.

SECTION 2: That the Fiscal Officer of the Village of Risingsun is directed to certify a copy of this Resolution, together with a copy of Resolution 2025-002 and the Certificate of Estimated Property Tax Revenue dated April 28, 2025, prepared by the Wood County Auditor, to the Wood County Board of Elections on or before August 6, 2025 at 4:00 pm, in order that this levy issue can be placed on the ballot in the Village of Risingsun for the general election scheduled for November 5, 2025.

SECTION 3. All formal actions of Council relating to the adoption of this resolution, and all deliberations of Council and any of its committees leading to such action were in meetings open to the public as required by law.
