

Fire Contract

This Agreement made this 26 day of August, 2025 by and between the **Board of Trustees of Jackson Township**, Seneca County, Ohio hereinafter called the TRUSTEES, and the **Risingsun Volunteer Fire Dept** of Risingsun, Ohio, hereinafter called FIRE DEPARTMENT;

Whereas, the FIRE DEPARTMENT has been formed and organized as a volunteer fire department for services in Jackson Township, Seneca County, Ohio and

Whereas, the TRUSTEES are satisfied that the organization of the FIRE DEPARTMENT is of such character as to give assurance of permanency and efficiency,

NOW THEREFORE, in consideration of their mutual promises as contained herein, the TRUSTEES and the FIRE DEPARTMENT agree to the following:

The FIRE DEPARTMENT agrees to furnish fire protection throughout the limits of Jackson Township, Seneca County, Ohio for a three (3) year term beginning January 1, 2025 through and including December 31, 2027 and in consideration for said fire protection, the TRUSTEES agree to pay the FIRE DEPARTMENT 10.5% of real estate tax monies received for the Fire fund.

The total sum will be payable in semi-annual payments due on the fifteenth (15th) day of June and the fifteenth (15th) day of December each year during the term of this Agreement.

IN WITNESS WHEREOF, the TRUSTEES of Jackson Township, Seneca County, Ohio, and the FIRE DEPARTMENT by their duly authorized officers, and pursuant to appropriate resolution, have hereto set their hands this 26 day of August, 2025.



Starting in 2025, Jackson Township would like to have new contracts with the fire departments based on the percentage of coverage that each department provides for the township.

Risingsun - 3.5 sq. miles = 10.5%

Bascom- 2.5 sq. miles = 7.5%

Kansas- 27.5 sq. miles = 82.0%
33.5 sq. miles

Average Revenue Based on the last three years: \$65,474
