A RESOLUTION OF THE VILLAGE OF RISINGSUN TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF RISINGSUN ON NOVEMBER 3, 2026, THE QUESTION OF ENACTING AN ADDITIONAL FIVE (5) YEAR .5 MILL LEVY IN EXCESS OF THE TEN (10) MILL LIMITATION FOR THE MAINTENANCE AND IMPROVEMENT OF VILLAGE PARK LAND.

WHEREAS, by Resolution 2026-003, the Council of the Village of Risingsun has determined that the amount of monies that may be raised within the ten-mill limitation by levies on the current tax duplicate will be insufficient to provide for the maintenance and improvements of the parks within the Village; and

WHEREAS, Ohio Revised Code §5705.19(H) permits the collection of such a tax for parks and recreational purposes; and

WHEREAS, the Wood County Auditor has provided its Certificate of Estimated Property Tax Revenue to the Village as required by law, which certificate states that the property valuation of the Village of Risingsun for purposes of estimating this proposed property tax levy is \$8,441,489.00, and that the proposed one-half (0.5) mill levy will produce an estimated annual revenue of \$4,221.00 for the life of the levy, provided tax valuations in the Village remain constant throughout the levy.

WHEREAS, the Council of the Village of Risingsun desires to submit the issue to the electors of the Village at the November 3, 2026 General Election, in compliance with RC §5705.191.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF RISINGSUN, WOOD COUNTY, OHIO, WITH TWO-THIRDS OF ALL MEMBERS VOTING IN FAVOR THEREOF:

SECTION 1: That for the purpose of continuing to provide the necessary funds for the maintenance and improvements of the parks within the Village, it is necessary to pass a one-half mill (0.5) levy, as authorized by Ohio Revised Code Section 5705.19 (H); that it is necessary to levy said tax outside of the limitations imposed by Section 2, Article XII, of the Ohio Constitution; that the question of enacting a five (5) year, one-half mill (0.5) parks levy shall be submitted to the electors of the Village at the general election to be held on November 3, 2026,

SECTION 2: That the Fiscal Officer of the Village of Risingsun is directed to certify a copy of this resolution, together with a copy of Resolution 2026-003 and the Certificate of Estimated Property Tax Revenue, prepared by the Wood County Auditor, to the Wood County Board of Elections on or before August 4, 2026 at 4:00 pm, in order that this levy issue can be placed on the ballot in the Village of Risingsun for the election scheduled for November 3, 2026.
